Reports:

<u>ADRC Financial Report</u> PCHS Account Specialist, K. Amsrud reviewed the 2022 actual budget report with the board, noting this is through June, 2022. Revenue for these reports always lag about two months, and neither budgets are overspent so financials look good. No additional or specific questions from the board.

ADRC Manager's Report ADRC Manager provided her report with highlights and updates from each of the aging programs since our last meeting in May. Also updated the board on the department's transition to a new director recently, as well as the resignation of Heather, the Nutrition Coordinator. Interviews for that position are scheduled for next week. Working on 2023 Budget prep, and several outreach events to highlight our programs and services. ADRC 101 'Get to Know Us' programs were very well attended; Final Affairs event is happening next month; planning Stepping Out Fall Prevention program for later this fall. Packet also includes Advocacy Training information for any board members interested.

A copy of the new policy (P-430 Transportation Write-Offs and Collection Policy) which was approved by the Human Services Board was provided. This is a situation that did occur and previously we had no policy on how to handle those accounts.

Senior Nutrition Program driver recruitment continues. Several public listening sessions are being held throughout August to just have discussions and gather feedback and ideas/suggestions from community members regarding the challenges involved with lack of volunteer drivers and providing home delivered meals for our program.

Business Items:

Draft **2023 ADRC** and **Aging Budgets** were presented by Karen. These are part of the agency-wide Human Services department budget preparation. Both budgets have a roughly 1.7% increase over the 2022 budget totals which is a minimal average annual increase and mainly due to salary changes. Final budget will be presented to the HS board for their approval at their regular September meeting.
