Business Items:

- June 1st Re-opening of Congregate Meal Sites for Buffalo & Pepin Counties: Nutrition Coordinator, Mylessa Ingli presented the idea and guidelines for re-opening the meal sites in both counties on June 1st. The board discussed pros and cons of a re-opening. Questions were asked about the mandate of masks. It cannot be mandated that volunteers or patrons wear masks. It can be recommended. There will be signage at each location to recommend masks and remind patrons to practice social distancing while in the site. Chairperson, Rita McDonnell entertained a motion for approval of the re-opening plan as presented. Motion was made by Tessa King and Brad Schmidtknecht seconded. Motion carried, all in favor by voice vote.
- 2021 Transportation Rates for Buffalo and Pepin Counties: Transportation Program Coordinator, Angie Schlosser, presented a report with increased transportation rates and the necessity of the increase. Chairperson, Rita McDonnell entertained a motion for the approval of the 2021 Transportation Rates for Buffalo and Pepin Counties. Motion was made by Robert Shutes and seconded by Ruth Leahy.
